## The Smoking Gun?

According to the Witness Statement of Jermaine Daniels, a sales assistant at Orange Retail Ltd:

'I can recall working at the Oxford Street branch on Friday 27th October 2006 and serving customers that day along with other members of staff.

I served a customer on that same day at around 17.06 or 5.06pm. The transaction was for the amount of £20 (twenty pounds) and consisted of two SIM cards, Serial No. ...2776

and serial No. ...3196. I cannot recall the customers details but I do know I served him/her as my name appears on the top of the till transaction receipt. I am a commission based employee and to obtain my commission I have to key in my operator No. when I carry out a transaction, hence my name appears at the top.

The transaction on that day relates to card No. (last 4 digits) 9391.

The two original receipts for that day have been misplaced due to an administrative error whereby slips for 27/28th October have been misfiled.'

## Lugavoy Confirmed

Andrei Lugavoy's Witness Statement is in accord:

'During the meeting of 26 October 2006 Litvinenko unexpectedly suggested to change the SIM card for me, explaining that it was inconvenient for him to pay for it and that he has fears the telephone may be listened to. I noticed that Litvinenko had a mania of being followed. He was hiding from everybody. I agreed to change the SIM card and that is why on the following day I took the one that Litvinenko had brought me.'

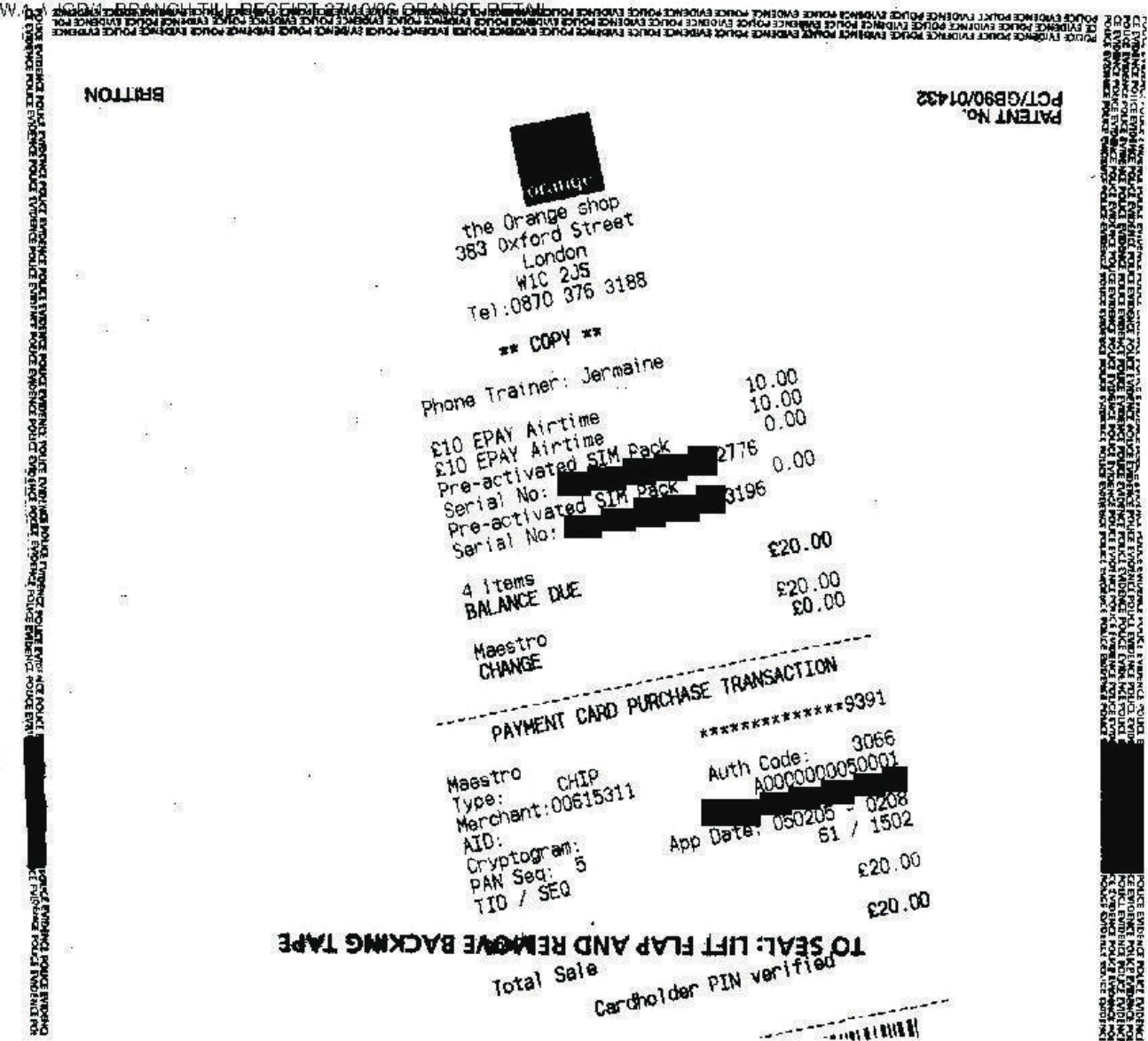
## Litvinenko

An excerpt, regarding 1 November 2006, from Detective Inspector Hyatt's interview with Alexander Litvinenko:

DI Hyatt: Okay, so you left ITSU and you went from ITSU to meet Andrei. Can you tell us more about that?

Litvinenko: Yes, I called him. I called him. We were due to meet at about six, maybe half past five. He said lets do it earlier, my meeting

has finished, but at the same time he asked me to buy him a new sim card for his telephone because his sim card was sort of finishing, the money, the money was finishing on the sim card. And this card was being paid for by Global Risk. Well, we don't feel comfortable asking them to pay for us and he said, I'd rather pay for it myself, buy me a new sim card and this card, I will pay myself. I quickly went to the shop in the street Oxford Circus.'

Further on in the interview:

DI Hyatt: Thank you, when, so you left ITSU and you went to meet Andrei can you tell us more about that? So you've left ITSU and what happened after you left ITSU?

Litvinenko: I called him and he said, 'Come here quick. I'm sitting in the Hotel Millenium'. It is next to the American Embassy.

DI Hyatt: And how did you get from ITSU to the Millenium Hotel?

Litvinenko: I walked.

DI Hyatt: Do you remember the route that you took?

Litvinenko: I don't remember exactly because I even had to look for it for a while because I had never been to the hotel before. But I always have a map with me so I found it. The street is approximately there...

DI Hyatt: Alexander you said after leaving ITSU you rang Andrei?

Litvinenko: Yes.

DI Hyatt: Alexander I have a map of the area. If I show you this map do you think it might help you tell us the route that you took?

Litvinenko: Lets try.

DI Hyatt: So for the purposes of this tape I am showing Alexander a

## Berezovsky

According to the Witness Statement of Boris Berezovsky, both Lugavoy and Litvinenko were in his office during the afternoon of 1 November:

'Further to my witness interview which I gave on 24/11/06 I have been asked to clarify some points around a meeting I had in my office of 1st November 2006 with Andrei LUGAVOY. Sometime in the afternoon I remember seeing Alexander LITVINENKO who I know as Sasha in the office he was using the photocopier, I do not know exactly what time this was, but it was in the afternoon, but he copied some papers I think there were two or three copies which he gave to me. He had already explained that he had some important information for me and that he had a meeting with an Italian man and it was important that I had copies of the papers the Italian had given him. After he had given me the papers I started to read them but I was in a real hurry and gave them to DUBOV who works for me as a Political Advisor but he is also my friend. DUBOV began reading the papers and Sascha said to me that he had told me the papers were confidential and that I shouldn't show them to anyone. He later said that as it was DUBOV it wasn't a problem as he trusted him. I think Sascha might have gone back to the photocopier at this point but I can't be sure. Sometime later I can't be sure when I became aware that Andrei

LUGAVOY was in the office. I wasn't sure why he was in the office it may have been that I had invited him to thank him for arranging security for my daughter who had recently moved to St Petersburg but I'm not sure. I believe I shook hands with him and invited him into my room. I went to my room and a short while later pressed the buzzer to my Secretary and asked if Andrei would like to come in to the room which he did. I have drawn a rough sketch of my room for police which I exhibit as BAB/1. I have drawn a solid line from the door to a column that I have marked with a cross, indicating the route Andrei took across the room. He stood by the column and I think he leant on the column. We were in conversation about my daughters security and I asked him to sit down. He sat down on the sofa nearest the column and I sat opposite. I have signed the box where I was sitting and I have drawn a box where I believe Andrei was sitting. I proposed that we had a drink and I remember than Nicoli GLOUSHKOV my friend had bought some wine for the office. I pressed the buzzer and asked the Secretary to help Nicoli with the wine, I don't remember which one of the girls it was. Nicoli then came in a shook hands with Andrei and said "Hello". I asked Nicoli about the wine and he said the wine was warm and I said, "Its better to have good warm wine than cold bad wine". Three glasses were brought into the room but Nicoli said that he wasn't drinking as he was in a hurry and then he left leaving myself and Andrei. I believe that Nicoli stayed on his feet throughout but Andrei may have moved along the seat to give him room if he chose to sit but I cannot be sure. Andrei and myself chatted for around 5 to 10 minutes. I was in a hurry as I had other things to do, I asked him if everything was



OK with the tickets as we had bought some tickets for him for the Arsenal CSK Moscow game and he said that everything was fine. We then shook hands and he left the office but I don't know where he went from there. I haven't seen him since, I haven't spoken to him on the telephone.

# Lugavoy Denied

On 01.11.2006 having sent my family with Sokolenko on a tour of London I telephoned Berezovsky's office again whereby it was confirmed to me that the (football) tickets are with them and I can take them. For

that I and Kovtun went to Berezovsky's office. I came to the office between 10 and 11 o'clock. I went up into the office, took the tickets, went down to the street where Kovtun was waiting for me, he did not go into the office. From Berezovsky's office we went for a short walk in the PICCADILLY area and walked to Shadrin's office. We reached there between 11 and 12 o'clock. As previously we were met by Shadrin and he took us into the same hall. The three of us talked, i.e. I, Kovtun and Shadrin. Sometimes, during the conversation, into the hall came Shardin's assistant and the secretary I mentioned earlier on. Our conversation went on until about 15 hrs 30

minutes. During this meeting Litvinenko called me several times on his mobile phone and was suggesting that we meet before the beginning of the football match. He said that he had something to say to me but did not specify what about. I suggested several times to postpone this meeting until the 2.11.2006 but he refused saying that it was necessary to meet specifically on that day before the match. He insisted on the meeting. That was typical of his character. He was an insistent person. I had planned to conclude the meeting with Shadrin at 15 hours 00 mins, suggested to meet with Litvinenko at the hotel just after three o'clock. He said that he might not be able to fit it

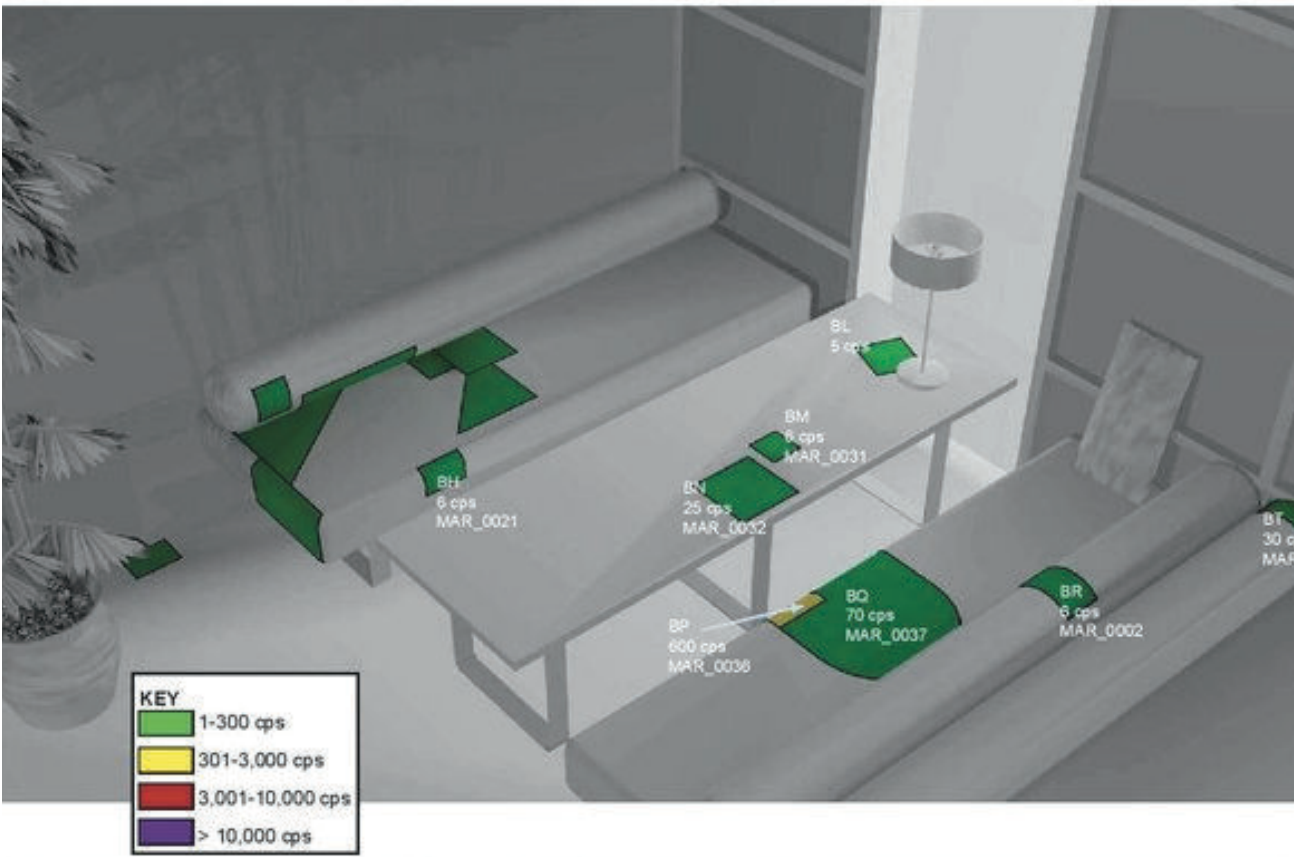
Further on in the interview:

DI Hyatt: And when that (Millenium Hotel) meeting was arranged what was the purpose, why did he, what did he understand the purpose of the meeting to be?

Litvinenko: Well the purpose, the purpose, actually, it was possible not to meet, but the purpose was just to see each other, we have good relations with him, personal. And to speak about Global Risk, what to do the following day, what is better.

DI Hyatt: Okay what can, can he tell us about the history of Andrei, how he knows Andrei and what Andre's background is?

Litvinenko: So with Andrei..... In 1994 in Moscow Boris Berezovsky was blown up, his car was.

Interpreter: In 1994 in Moscow was what?

Litvinenko: In Novokuznetskaya Street was blown up... well, there was an attempt to blow up Boris Berezovsky when he was leaving his office in a car. And I met him then. Because I was in the group which was dealing with this case.

I gave the £20 to the man in the Health Food Shop at Warren Street.

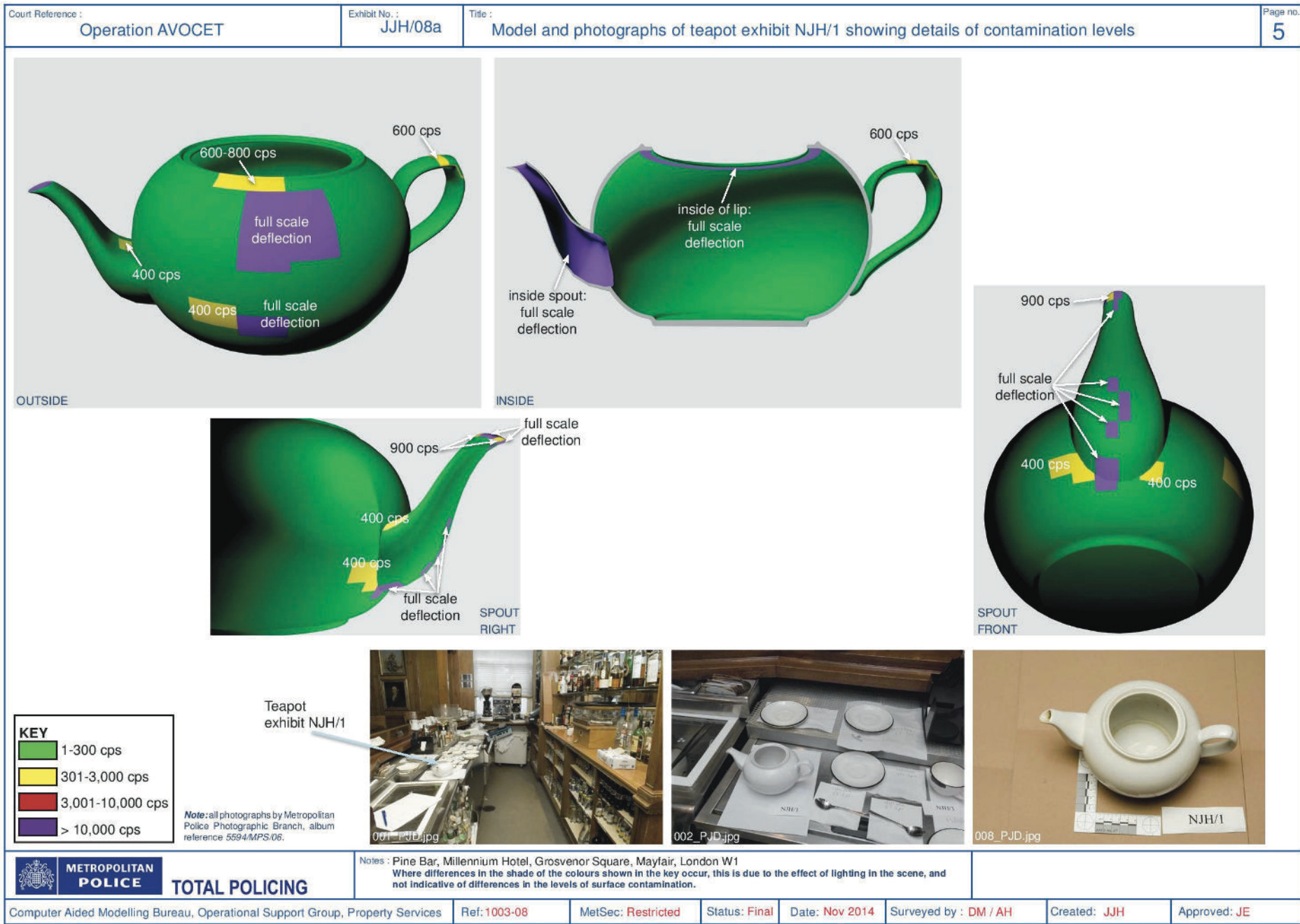

## Dr Harrison

According to the Witness Statement of Dr Harrison:

'An initial increase in neutrophil (also referred to as granulocytes) numbers above normal levels was observed on 3.11.06 and 5.11.06, characteristic of high dose radiation injury. Bearing in mind the protracted delivery of dose from polonium-210, this is consistent with intake on or around 1.11.06.'

Dear Mr Cameron

Can you confirm that the Inquiry will not have anyone challenging what could reasonably be described as the prosecution case? The Orange receipt might be the key to the case. There are anomalies such as contamination on the bathroom floor not trampled into the bedroom, and the heavily contaminated pillow (had they not washed the pillow case?) at room 302 Millenium Hotel; the coat hanger and lack of contamination spread in Best Western Hotel; and no polonium having been blown or brushed to the floor despite heavy contamination at Erinyes.

There is also the important issue of Litvinenko's jacket.

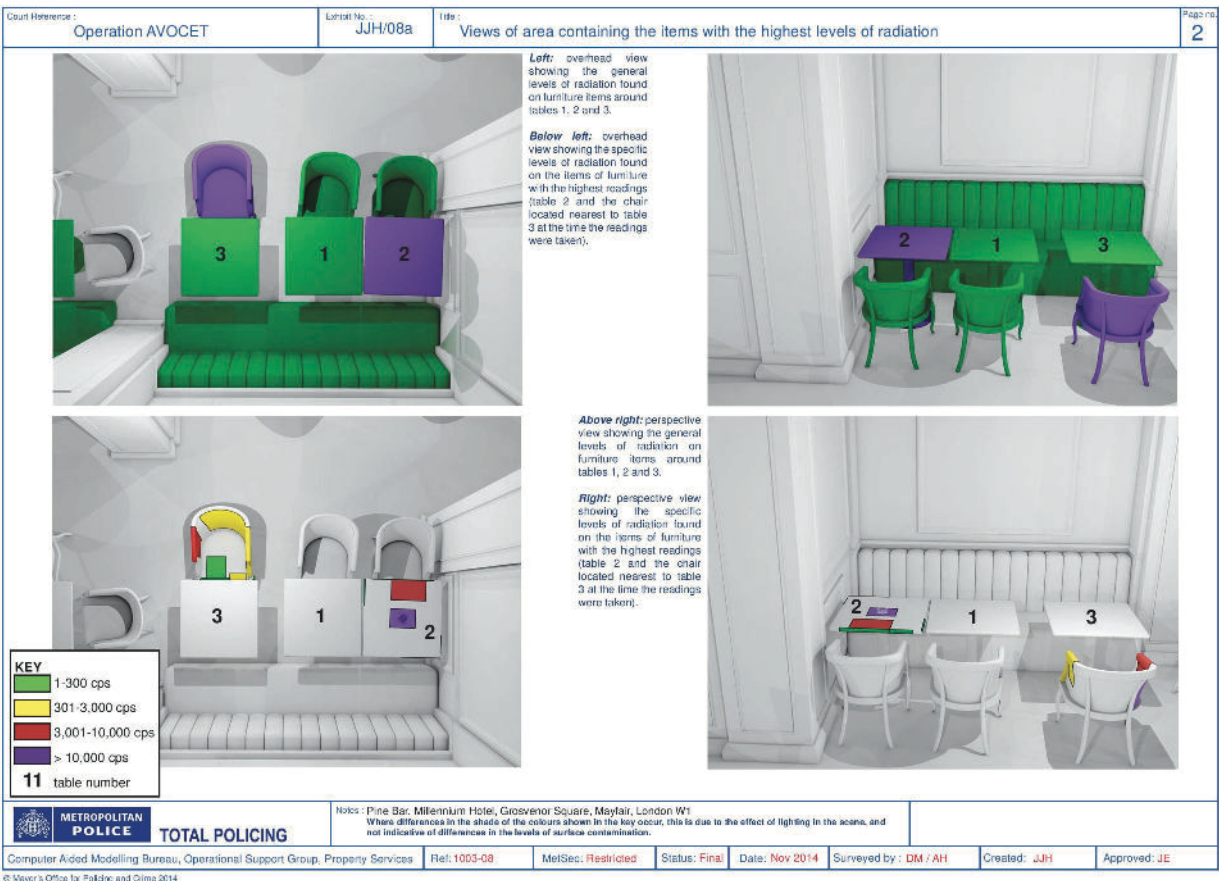
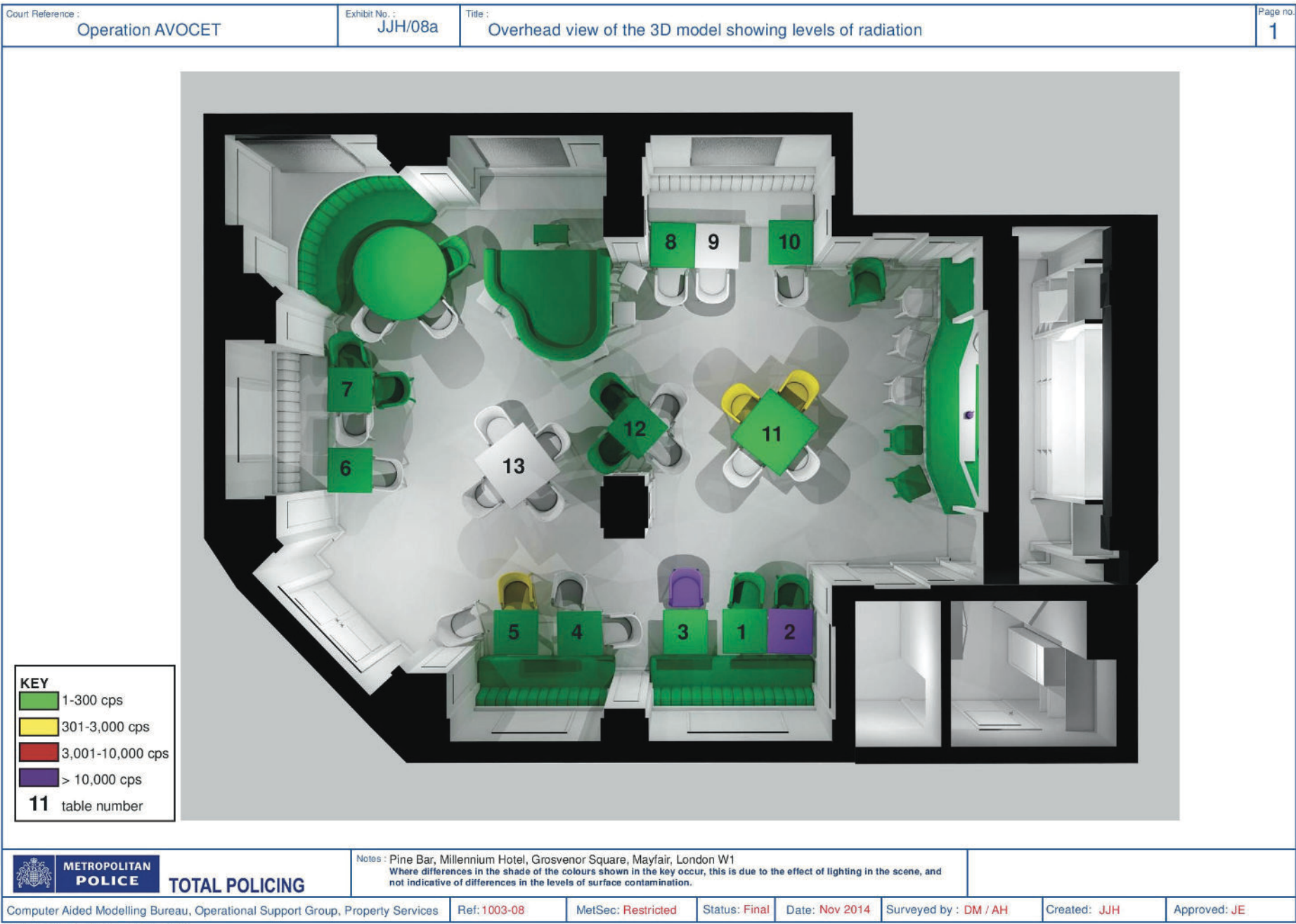

## MARIO SCARAMELLA (MS) / PAOLO GUZZANTI (PG) - SECURITY-2

1. Names of MS and PG are often mentioned in confidential talks of intelligence officers of Russia who work in SVR, Kremlin, Shevchenko's RNSSES and (starting from August 2006) "SVR veterans association DIGNITY AND HONOR" (Moscow, headed by acting SVR colonel Velichko Valentin).
  - 1.1. All SVR officers are sure that PG and MS still closely collaborate with "enemy No1 of Russia" - Boris Berezovsky and his "companions-in-arms" - first of all A. Litvinenko and V. Bukovskiy.
    - 1.1.1. They suspect that recent rumors initiated by Litvinenko about his receiving of the UK citizenship are false, are designed to mislead Russia's endeavors to obtain his / Berezovsky extradition to Russia and are (at least partially) inspired by PG / MS, who, in their turn, try to obtain citizenship of Italy for Litvinenko for his "outstanding services for the 'Mitrokhin commission' investigations", which are in considered in Moscow as purely provocative towards Russia.
    - 1.2. A.m. intelligence officers also think that MS and PG in fact formed "stable criminal group which serve interests of the most conservative / rightist wings of special services of Italy, USA and UK", falsify investigations and reports on KGB / Russia international affairs and seek to profit from it by any possible mean (including financing from SISMI, FBI and CIA).
      - 1.2.1. In the frames of this general understanding they take all activities of and latest developments connected with MS and PG.
      - 1.2.2. They think that the case of arms traffickers - Ukrainians (now under court hearings in Teramo, Napoli region) and presumable attempt to assassinate PG in November 2005) were trumped up by PG and supported by false evidence of A. Litvinenko, set up by Ukrainian "unscrupulous" friends of MS from secret services. They say this case is under investigation now in Kiev in SBU and very likely "plot will be revealed with help of Russia's colleagues".
      - 1.2.3. Anyhow, possibility that Russian intelligence side could be involved in this attempt seems to be invalid (there is no single indication on it).
2. Meanwhile above mentioned Russian intelligence officers speak more and more about necessity to use force against PG and MS, considering their "incessant anti-Russian activities" - as well as against Berezovsky and Litvinenko.
  - 2.1. The most troubling and dangerous development is Velichko's involvement into planning of actions against PG and MS. (Velichko and his fund are well known in the security community in Russia and Europe, mostly because it was him who "liberated" MSF's representative in Dagestan Arian Erkel in April 2004, in cooperation with SVR / FSB, for the cash ransom of USD 1 mln, paid by the Netherlands' government, which is still under legal proceedings against MSF (Geneva) on this case. Besides, Velichko's agents are presumably involved in the assassination of Anna Politkovskaya in October 2006 as well as in elaboration of other similar assassination plans in Russia and Baltic states - by order and on behalf of FSB / SVR...)
  - 2.1.1. Yesterday an agent who works with Velichko's deputy and closest collaborator Ubilava Anatoliy (intelligence officer) said that Ubilava mentioned that he has an agent who stays in Napoli for over 1 month already, follows up displacements of MS and PG (who visit the Teramo court hearings), has local network of KGB agents at his disposal and prepares "final act" (could be serious provocation or even assassination attempt - Ubilava at least once mentioned that it's "decided by our superiors", meaning chiefs of SVR (or FSB)).

# Witness Statement

This might be a rather bizarre Witness Statement. If I edit, remember anything, even having my recollection jogged by something revealed at the Inquiry, whoopy do.

On a date I believe to be 1 Nov 2006, it was certainly around then, I arrived in the CCTV covered Hilton Subway at 4.20pm according to my mobile phone. Shortly after I arrived, at a time I would approximate at around 4.24pm, a man placed £20 in my flute case. I said, "Thank you" as the man walked on.

Immediately, Jesus prompted me that I knew who he was. Jesus told me I would be able to remember who it was. Jesus quietly told it was the spy Alexander Litvinenko and that I had seen him before, and that I had seen him with Mr Berezovsky, that I had seen him among Mr Berezovsky's entourage.

Jesus reminded me I had been expecting an assassin, and told me the £20 was poisoned and Litvinenko was the assassin.

I saw Litvinenko walk by. He was wearing all light coloured clothes.

I was aware that although Litvinenko was alive and walking through the corridor, he was already dead. He was already dead, he fate had already been sealed and he was about to go through a long dark corridor. He was already in the long dark corridor.

Again I saw Litvinenko walk by. It might have been at this point I noticed he was wearing a light check beige shirt, virtually white denim

jacket, light beige trousers, cream shoes; and holding a paper folder contained within a larger clear transparent zip lock bag.

I was aware I kept seeing Litvinenko walk by.

The vision was quiet and Jesus told me that I would quickly forget the vision and about Litvinenko, and that he would make me remember later.

Jesus showed me Litvinenko as an angel of Lucifer.

(I have omitted a part)

I wondered what to do with the £20. I decided to put it in a usually unused left pocket.

When I finished the pitch, Jesus appeared cheerfully in Spirit form and told me that a famous spy had given me £20 and that I was lucky to get that £20. Jesus told me I was lucky to get that £20 as there was a radioactive material called polonium 210 on the £20. Jesus told me it was didn't matter if you got it on your hand as you could wash it off, but it was very dangerous and a little bit could kill you if it went in your mouth. Jesus told me the famous spy was Alexander Litvinenko, who was one of the Russian dissidents in London and that I had read about him. Jesus told me it was nice of Alexander Litvinenko to have given me £20. Jesus again said it was nice of Alexander Litvinenko to have given me £20. Jesus told me there was polonium 210 on the £20, and that Litvinenko had tried to kill me. Jesus told me I was paranoid and that Litvinenko had

tried to kill me. Jesus told me I was paranoid and that he wanted people to go along with the paranoia, that he wanted people to believe Litvinenko had tried to kill me. Jesus told me he wanted people investigating to take the premes that Litvinenko trying to kill me was the major thing that had happened that day, and to work through what had happened from there. Jesus assured me that Litvinenko had tried to kill me.

Jesus firmly told that MI5 had not tried to kill me. Jesus told me he had told me that because otherwise I would believe it was MI5. Jesus cleared MI5 and said MI5 were not involved.

Jesus told me the attempt to kill me was the major thing that had happened that day.

Jesus told me I was an add on to the plot against Russia. I saw Iran.

Jesus told me that I was the target. Jesus pointed out I was a big one and that the message in Eye Say of Private Eye, 'The gospel of Mark has 666 verses. The resurrection of Jesus is written in John.' had not just been read by British people. Jesus said that other governments were worried and that the Italian government in particular was worried.

Jesus told me he was pleased with me for the message. Jesus pointed out it did worry governments and that the Italian government was worried.

I considered a better approach was via John 21. Jesus smiled and was pleased with me.

I noticed by Jesus' smile and warmth that he was more pleased with the John 21 approach than the Mark and John message.



Jesus told me that the messages before the invasion of Iraq was a big one. Jesus told me he was pleased with me for those messages, and told me they worried MI6 and that they were more effective than the anti war journalists. Jesus told me the messages had influenced journalists and people. Jesus told me he particularly liked, 'Unlike Britain and America, Iraq had no weapons of mass destruction.' which I had placed shortly before the invasion. Jesus told me the uranium message was good. That was the message with 150.

Jesus told me the Iraq messages were good and had angered MI6.

Jesus - pointing out he was not referring to the Iraq messages - told me that as a general point that I was harsh on governments. He told me that it I should try to make my point in a way that made things easy. Jesus told me that you could make a point in a way that angered people, or make the same point in a way that made things easy. Jesus told me you were more likely to succeed if you made the point in a friendly way.

Jesus pointed to the message about Mark and John. He told me that governments worried and and that going by John 21 made it easier for them.

I saw Mr Berezovsky. Jesus pointed out Mr Berezovsky was important and I had forgotten. I was worried because I had forgotten. Jesus pointed out to me a few things had quietly happened when I was walking up Mr Berezovsky's street, and reminded me he had told me to walk up Mr Berezovsky's street. Jesus pointed out I had done nothing wrong.

I was aware Mr Berezovsky was im-

portant with regard to Litvinenko.

Jesus told me there was just a little polonium 210 on the £20, that he had ensured that it had mainly gone on Litvinenko. He told me the polonium 210 would kill Litvinenko as it had gone in his mouth. Jesus told me Litvinenko had to die for him.

Jesus told me that although there was just a little polonium 210 on the £20, a little bit of polonium 210 was very dangerous.

Jesus was particularly cheerful. I considered the situation was very dangerous and his cheerfulness was to help me. Jesus told me it was dangerous and that he liked that and he was with me and he was genuinely happy. Jesus explained that he did not cause dangerous situations - he pointed to a few British people high up - but when someone else caused a dangerous situation and he was protecting someone, he enjoyed it.

I saw an old Soviet nuclear power plant and this part was dark, and I was dingly aware that was where the polonium 210 had come from. Jesus told me that the old Soviet power plant was where the polonium 210 had come from. I noticed that Jesus telling me about the old Soviet power plant was dark. Jesus seemed dark and dingy so I was suspicious. Jesus showed me that the Soviet scientist at the old power plant had refined polonium 210 down to billionths of a gram. He was the only person who could do that. When the power station was due to be closed, they had wondered what to do with the polonium. They had decided some should go to the KGB, which was them. It went to a cell in the KGB, who had illegally got it from the power station. It was individuals acting illegally.

Although it had not yet happened, I was aware there were 2 Russian associates of Litvinenko who were accused of murdering him. Polonium 210 would be found on them. I realised that polonium 210 was found on them meant it was found that one of them had polonium 210 on his jacket. I noticed that sentence about the jacket was lighter. I also aware you could have false light. I noticed that Jesus had not endorsed the part about the jacket.

One of the 2 Russians was called Koftun and he had a stockpile. That was dark. People wondered where Koftun kept the stockpile. Koftun had a few homes, he was a wealthy man, and he had a house in the countryside. There was a large painting in the living room which Koftun liked to look at and liked to show people. It was his favourite. The polonium 210 was it at his home in the countryside in the frame of that painting. I would later have a dream to remind me of this part of the vision, about the stockpile being in the picture frame in Kofton's house in the countryside.

I considered the polonium 210 that had been used on me had come from Anglesey. I noticed that sentence was light. I was pleased as the previous paragraph - I was aware it was a paragraph - about Koftun was dark. I was aware the bit about Koftun's house was brighter. I could tell it had come from Anglesey. I had picked up the 50 pound note and polonium 210 had gone on my hand and on my lower arm, it was Anglesea. Jesus was cheerful and pleased with me and told me it had come from Anglesey. What Jesus said was light. Jesus cheerfully told me to tell them the polonium 210 had come from Anglesey.

I knew you had to pay attention to



the way Jesus told you something. In the bible, some of what he said to his disciples depended on the way he said it.

Jesus told me the famous spy was Alexander Litvinenko, that Litvinenko was one of the Russian dissidents in London and I had read about him. Jesus quietly told me that Litvinenko was infamous in Russia. Jesus told me that Litvinenko was seen by most Russian people as a bad spy, and was seen through rose tinted cold war glasses in Britain because he had defected from Russia, that in Britain he was generally held in high regard; and that the Russians knew him better and the Russian people were correct about him. Jesus told me there were quite a lot of bad spies and that Litvinenko was a particularly bad spy.

Jesus told me I was lucky to have been given that 50. He told me that many Anarchists wanted to have polonium 210 and it had been given to me. I was aware some people thought I should give the £50 to the police. Jesus told me not to as they would not believe me and the polonium 210 would harm the police.

Jesus told me he wanted me to spend the 50 at the Health Food shop at Warren Street. He told me it would not harm anyone if I gave it to the Health Food shop. He told me to buy a curry, Devils Claw and Propolis from the Health Food shop. He told me not to wash my hands until after I had been to the Health Food Shop. Jesus told me I was to wash my hands at Euston.

Jesus told me giving the £20 to the Health Food Shop was more Anarchy than giving it to the police. Jesus told me people high up in the organisation went to that Health Food Shop.

Jesus pointed out to people that this vision was particularly intense and Jesus telling me about Litvinenko and polonium 210 on the £20 seemed crazy to me and I did not know what was going on, and that I would forget the vision other than in flashes - Jesus pointed out to people the vision was intense and transitory - and Jesus would repeatedly instruct me to buy Devil's Claw, Propolis and a curry, and I would generally forget the rest of the vision and follow the instruction.

I was aware some Christians were unhappy that Jesus talked to an Anarchist. Jesus pointed out he was not getting involved in that, and that he was for people right across the political spectrum.

Jesus explained that when he spoke to people, he took their view into consideration and tended to come from their angle. Jesus said that when he was talking to a socialist, he might give them an idea for the NHS and tell them that was what Nye Bevan would have done.

Jesus told people Litvinenko had tried to kill me with polonium 210 and he was rescuing.

I was aware some Christians were unhappy because they lived lives acceptable to society whereas I smoked and drank and Jesus often talked to me. I was aware I didn't drink but that I would later and I had before.

Jesus pointed out to people that the reason he often spoke to me was because I told people what he had said.

I was aware Russians would be happy if I told them I was crazier than Balaam.

Jesus smiled warmly at me and told

me he was pleased I as an Anarchist, and that he had been a bit of an Anarchist back in his day.

Jesus explained that when he reflected the person he spoke to. Jesus pointed out to people that the books of prophecy in the bible reflected the prophets.

That was something I had noticed. I had thought that John was afraid of dogs. I was aware it could be figurative for people who behaved like dogs. Jesus said it was about people who behaved like dogs. I still thought John may have been afraid of dogs. Jesus smiled at me thinking John had been afraid of dogs.

Jesus said there was a good one in Isaiah. Jesus said the best example was in Isaiah.

Jesus told me that currently Russia had the best spies. Jesus explained that when he said best spies, that meant the most well behaved. Jesus was looking at Britain, Russia, France and America when he said Russia currently had the most well behaved spies.

I noticed Jesus had looked at Britain first, then Russia then France then America. As Jesus looked at Britain, he was smiling at what was going on in the towns and cities, he smiled at quite a lot of them and particularly smiled at Birmingham. I wondered why he was not looking at towns and cities rather than the countryside. Jesus then looked only at London and was smiling. He told me there were amazing things going on. I was puzzled. Jesus told me there were amazing things going on in London that I did not see because I did not work in the city. He told me there were people in the city doing amazing things. Jesus said amazing things were happening in London



such as people getting married and having children.

Jesus examined Britain and was glaring angrily at MI6. Had a look at MI5 and thought they were OK but he was really angry at MI6. I noticed it was for a long time that Jesus was glaring angrily at MI6.

I wasn't happy that Jesus had said MI5 were OK. I wanted Jesus to glare angrily at MI5 and preferably destroy them. Jesus had another look at MI5 for me and told me they were OK. Jesus looked more closely into MI5 and said there was a bit of trouble with them but they were generally OK. Jesus told me he knew more than me and MI5 were generally OK.

Jesus, exasperated with me, told me I gave MI5 a hard time. He told me there were nice people in MI5 who read what I wrote about them, and told me I wrote of a few of them as if it were all of them. He showed me a nice MI5 woman who read Jesus speaking to me and then read what I said about MI5. Jesus told me there were a few bad people in MI5 but it was not them all. He told me there were people in MI5 who believed in him and there were people in MI5 who wanted to protect me, that many of them were trying to protect everyone and that included me. Jesus told me that I thought everything that happened was MI5 and it wasn't always them.

Jesus went back to glaring at MI6. He was furious at MI6. Jesus looked at Iraq and was absolutely furious at MI6 for the Iraq. Jesus said a lot of Iraqi children had died because of MI6. Jesus continued to look at MI6 and was absolutely furious with MI6 for the plot against Russia. Jesus kept looking at MI6 and was livid they had tried to kill me. I noticed

from watching Jesus that the plot against Russia appeared near in time but separate from the attempt to kill me. Jesus told me the attempt to kill me was an add on.

Jesus told me the plot against Russia was large and had begun in 2003.

Jesus kept looking at MI6 and told me they would later do the same to Libya as Iraq. Jesus was furious at MI6 for what they had done to Libya. Jesus kept looking at MI6 and told me there were other things he was angry with MI6 for and that it had been going on for a long time.

Jesus angrily told me that the plot against Russia could have caused war with Russia, that it could have caused reprisals and escalation, and that it was because of the wisdom of Vladimir Putin that that hadn't happened. Jesus said that the wisdom Putin had shown was the wisdom which Jesus had given him. Jesus told me the wisdom Putin had shown in that matter had come from the bible. Jesus told me Vladimir Putin would be rewarded for his restraint and Russia would be rewarded, and that God the Father was going to punish MI6.

I considered there would be a problem in Syria in 2012 and that in my opinion Putin would make a mistake by being involved. I was aware Jesus had not told me there would be a problem in Syria. Although Jesus had not told me in the vision, I was aware Jesus had programmed the vision. I saw Syria and Putin in Syria go up in flames in 2016.

I saw Iran appeared through a faint cross hair in 2015.

I noticed Iran appeared through a cross hair in 2017.

Jesus had a look at me (what I had considered) and confirmed there would be a problem in Syria in 2012. Jesus departed saying he would deal with what I saw about Syria and Putin in Syria further on in the vision.

God told me he was going to take revenge on MI6 for Iraq, Russia, me and everyone. God told everyone not to take revenge on MI6 but to leave it to him. God told me there would soon be a very mysterious death of an MI6 agent, that it would be after the death of Litvinenko, and that the very mysterious death would be an act of God for which God accepted responsibility.

God told me that some people thought one death of an MI6 agent was not enough. Got said not to underestimate that one as it was very mysterious. God told me that the very mysterious death of an MI6 agent, which would be after the death of Litvinenko, would shock MI6 and all the MI6 agents would be afraid. I noticed that God used the phrase 'very mysterious' each time he referred to that death. God told me that he was pleased MI6 would be shocked but it was most important to him that they were afraid, and that all the MI6 agents would be afraid.

God quietly told me, "I have heard the Hawkwind song The Secret Agent from the little Hawkwind album Electric Tepee. I am aware of the 1st track on that album. The 1st track on that album would be a gateway to hell. Many people who liked Hawkwind, and also Hawkwind, were in danger of going to hell through that track. Hawkwind are particularly in danger of going to hell through that track. I am not happy about that track. I will forgive Hawkwind for that as The Secret



Agent is a good song. Electric Tepee is not a major Hawkwind album (God indicated to me that there was a major Hawkwind album on Electric Tepee) but The Secret Agent is a good song which would have gone on any major Hawkwind album. I particularly like listening to the major Hawkwind album from 1977 with Robert Calvert singing."

I thought the 1977 album was overrated. I thought it was very good but I preferred some of Hawkwind's later albums. God disagreed and told me he preferred Hawkwind with Robert Calvert singing.

God told me he particularly enjoyed listening to Robert Calvert singing Damnation Alley.

I was puzzled as I knew from a previous vision that Jesus preferred Hawkwind with Huw Lloyd Langdon, and that Out & Intake was Jesus' favourite Hawkwind album. Waiting For Tomorrow was Jesus' favourite Hawkwind track.

God told me he liked Hawkwind with Robert Calvert singing because those songs were of consistent high standard, rarely dipping below 8 out of 10. God explained that consistency was why people liked Hawkwind with Robert Calvert, and that although those songs were of a consistent high standard, only one was one of Hawkwind's best tracks. God said that while later Hawkwind lacked consistency, some of the individual tracks were 10 out of 10. God said later Hawkwind lacked consistency but some individual tracks were outstanding. God pointed to Hawkwind in the 90s as being inconsistent, and pointed to Xenomorph from Alien 4, and The Secret Agent as 10/10.

God told me that Little Electric Tepee was a major Hawkwind album

and that there were 5 tracks on it:

1. Mask of Morning
2. Sadness Runs Deep
3. Going To Hawaii
4. Right To Decide
5. Death Of War

God told me that was Hawkwind's best album and that Jesus would remind me later.

Jesus told me that although some of Hawkwind's best tracks were on that album, they were to remain on Little Electric Tepee and were not to be considered for the compilation of Hawkwind's best 10 tracks.

God told me that if Little Electric Tepee was sold for the same price as big Electric Tepee, Little Electric Tepee was better value. God told me people would like Little Electric Tepee and would enjoy Alan Davey's very good bass playing.

God told me that although The Secret Agent was one of Hawkwind's top 10 tracks, it did not fit with Little Electric Tepee, that you had to consider the cohesion of the album, and that The Secret Agent was instead to go on the compilation of Hawkwind's 10 best commercial tracks.

I considered it was strange that Litvinenko had tried to kill me and there was polonium 210 on my hand and my arm, and in my pocket and presumably on my trousers, and God was talking to me about Hawkwind. I was aware this was a vision and that it was a long one, I understood why Jesus had told me about Litvinenko and the polonium 210 but it seemed to have taken a detour and I was puzzled why God was talking to me about Hawkwind.

I was aware this was a dream. I was in the Hilton Subway.

God told me that Hawkwind were an important band and that while he was talking to me I didn't know what I was doing with my arm. God told me it was important I didn't know what my arm had been doing. God shook his arm to indicate my arm had been shaking. I didn't know whether I had put my flute away.

At some point (maybe later), God told me I had put the flute away and had been shaking the headpiece of the flute with my arm, as normal when packing away, and that polonium 210 had come off while I was shaking my arm. God told me Daniel would later sit there. God told me my arm had been doing things and it was important I didn't know what I was doing. God told me that while I did not know what I was doing he had controlled the way I put my flute away so that I did not contaminate my left hand.

"I particularly like Dave Brock's guitar on The Secret Agent and they all played their instruments well on that track."

God then quietly told me, "If there was an album of Hawkwind's truly best 10 tracks, The Secret Agent would be on that album."

God told me that an album of Hawkwind's truly best 10 tracks would be a good album and I was to pick the 10 tracks and the order that they were to be on the album. God told me some people would want to change one track but it was to be the what I had chosen and the order of the tracks was important and was to be as I had chosen. I was aware the order would be generally chronological but there would be anomaly,



only for reason of narrative.

God and Jesus told me Dave Brock would be pleased with me for the Best of Hawkwind album.

God told me we would pick the tracks later in this vision.

Then God told me, "As I know you like Hawkwind, and The Secret Agent is a good song, I will make the very mysterious death of the MI6 agent to be a little bit linked to that track."

God said that he had helped Dave Brock with The Secret Agent and Dave Brock had put it on the album for him and he was pleased with Dave Brock.

God was in front of me and was like coming up from the ground and his head was lower than mine. I was uncomfortable that I was taller as I considered some people might imagine. Jesus was standing in the middle of the subway smiling as he watched God talking to me. I was aware he could appear in different ways to different people. Here, he was dark. Although he was dark it was good quality dark. He was very powerful. The dark appeared liquid, I thought like treacle. God told me it was oil as he had decided to appear as oil. God told me he was flowing like oil. I noticed Jesus was wearing a Stetson. It seemed strange that I was in the Hilton subway with God talking to me as oil, and Jesus wearing a Stetson. I wondered if there was anybody passing by who saw me and noticed anything. God told me to look at the ground. I looked at the ground as saw there was lots of God as flowing oil and coming up from the oil was like an oil being which was where God was speaking to me. God told me there was lots of him coming up from the ground and that

he had decided to appear coming up from the ground as people had thought he was dead and buried. God told me he was alive and well and was flowing up from the ground all over in lots of places, having had decided to appear dead having decided to go underground in the sense of The Underground that hippies spoke of like in the Hawkwind song Days Of The Underground. God told me he liked that song and wanted it on the album. Jesus interjected that there was a reference to LSD at the start of the song and said the album was to be free from references to LSD. God agreed with Jesus. God told me it was a shame there was a reference to LSD as it was a good song and commercial it would otherwise go on the album, and he liked the verse with Pete and the other characters, which was why it would otherwise have gone on. God said we were choosing the best 10 tracks and that the lyrics were taken into consideration, and that as there was a reference to LSD, that was poor lyrics and we would go with Damnation Alley instead.

Jesus said that although there was an oblique kind of reference to LSD near the beginning of Kadu, it was a reference to not taking LSD, and the 'I want to get high' was clearly a reference to climbing Katmandu, so Kadu could go on the album. I noticed Jesus used Kadu as the song title. Jesus said there was very good music in Kadu and the album should start with that.

Jesus said more people would buy the album if that track was called Kadu. Jesus said Kadu had an effect on women and that there were a few women who had never listened to Hawkwind who would buy the album just because the opening track was Kadu. Jesus said that if the album was for sale in Tesco, the open-

ing track was Kadu and the cover was plain black with a single red rose, many women would buy it, more women than men, and more people would buy the album if it was for sale only in Tesco than if it was available online. Jesus said it was better to sell the album only through Tesco.

God, smiling at me, told me another reason he was talking to me about Hawkwind - and for him appearing as oil and Jesus wearing a Stetson - after Litvinenko had tried to kill me; was it was important for MI6 to know not to try to kill me because I was a psycho. God told me he would be pleased with me if I remembered that part of the vision. God was smiling at me as he knew I knew that psycho meant God was with the person. It was psycho in its true meaning. God agreed and told me I was a nice psycho.

Robert Calvert had appeared in the Hilton subway and I noticed I was standing on the side of the tunnel to where I had been previous. I was aware it was a dream. I was aware dreams were linked to visions, that visions were dreams, and that many sections of vision at the Hilton subway appeared later in dreams at night later. They were to remind me and help me write, it had all happened while I was standing in the Hilton subway.

Robert Calvert was standing nearby God and Jesus in the Hilton subway.

Robert Calvert told me he knew about The Best of Hawkwind album I was doing with God, and that he was happy with Damnation Alley being the only track with him singing. He told me he knew I would initially have Lost Johnny on the album, as he was with God and Jesus, before I had properly exam-



ined the vision, and he told me to remove Lost Johnny and have Huw's track Rocky Paths as was better as it had better lyrics, was commercial, uplifting, had Huw's guitar and Jesus liked it.

Robert Calvert said many people assumed he had gone to hell, and he pointed out he was in the Hilton subway standing near God and Jesus.

He told me he believed in God and Jesus, and had believed in them when alive, had that he had been ordained by God and Jesus to give a message to me.

Robert Calvert told me not to go Mark 666 and to go via John 21.

Jesus agreed with Robert Calvert and told me he wanted me to tell people about Mark 666 to show people John's vision in Revelation was good, after going via John 21. Jesus told me Revelation was an important vision and to go via John 21 to make it easier for people.

God told me I would have to chose the tracks, to wait until 2012 as there was something on an album in 2012. God told me the album was to be commercial, but no tacky commercial, and there were to be no drug references (God indicated Elric was OK). God told me I was to chose by the music, the band performance - God told me there was a good band performance on the track on the 2012 album - and the lyrics. God told me the lyrics were important and that if I had to choose between a few songs to go by the lyrics, and told me he liked the lyrics of Xenomorph - the skeletal life forms. God told me not to pick tracks for the space heads but to pick tracks that everyone would like. God told me we could cut a long story short

and I could write the tracks in their correct running order at this part of the vision here:

1. Kadu
2. Aerospaceage Inferno (Onward)
3. Forge Of Vulcan
4. Xenomorph
5. Elric (The Enchanter)
6. Damnation Alley (from guitar)
7. Black Elk
8. Lost Johnny
9. Secret Agent
10. Waiting For Tomorrow

God told me I would have to consider the running order and consider the cohesion of the album, and to pick tracks for the cohesion of the album.

God told me that was a very good album and was commercial and was the very best of Hawkwind as it was their 10 best tracks, the album was called The Best of Hawkwind and that it would be popular and that the cover art should be with consideration so that they would sell it at Tesco. God told me it was a very good album which ordinary people who had never listened to Hawkwind could buy and enjoy.

God pointed out to other people that while He and Jesus had helped me, they had pointed out more than 10 tracks, and I had to chose 10.

I thought I should leave the artwork to them. I realized I was in a deep vision after Litvinenko had just tried to kill me, God had done the album with me and I wondered if any I would be told any art. I didn't think there should be a picture of me on the cover. Litvinenko had indicated in the vision that he wanted to go on the cover. Richard Chadwick, Hawkwind's drummer, appeared beside me in the Hilton Underpass and told

me he didn't think Litvinenko should go on the cover, that he thought just a rose should go on the cover as it was The Best Of album. The Hilton Underpass had nearly disappeared from view.

Richard Chadwick appeared beside me again and told me a single red rose should go on the cover. Jesus agreed with Richard Chadwick.

Robert Calvert told me he thought Litvinenko should go on the cover.

I was aware I was completely gone. I considered some people would think I was on LSD. I hadn't taken any drugs that day. I hadn't taken any drugs that month. I considered some people would think it had happened because I use to take LSD. LSD visions were not clear. I had never experienced anything like this on LSD. I believed this was God and Jesus talking to me. I had taken a lot of LSD when I was younger, and considered LSD visions low calibre in comparison. What had happened here in the Hilton tunnel was infinitely superior.

The Hilton Underpass had now completely disappeared from view. I couldn't see my surrounding at all. Although I couldn't see the underpass, I could see Jesus and God who now appeared like cartoon characters, in a manner I was aware other people would think was suggestive of me being mad.

Jesus appeared worried about me and about where I was going.

Everything had changed, it was dark and it was like matter had gone and I was in the spirit world. Jesus and God had disappeared and it was dark. Although there was no matter, I was still in the Hilton tunnel and Litvinenko had still gone through



the tunnel and round the corner on the bus, and the Hilton was still on the other side. It was just all without the material. It was the spirit world and a murder had happened. Murder in the spirit world was a terrible thing. I was aware it was also a terrible thing in the real world. Litvinenko had been murdered on the bus. I realized Jesus had made Litvinenko put his hand to his mouth. It was on the bus that Litvinenko had died. Jesus did not murder. I considered it was not Jesus who gave Litvinenko polonium 210.

God was with me and was inside me. Jesus was with me and was inside me. This was the same part of the vision where it was the spirit world. As God and Jesus were inside me, it was the best part of the vision.

Jesus told me the first meeting Litvinenko had was very important and where the polonium had come from. Jesus told me the first meeting Litvinenko had was with 2 MI6 agents at Etos. Jesus told me that the London branch of Etos was really MI6. Jesus told me it was Etos who had been moving polonium 210 around, that I would remember Etos, and that when I googled Etos I would find a company called Etos Partners, and on their site would notice the word 'Orthopaedic', which I would know was linked to dentistry.

God told me that years later they would re-investigate the very mysterious death and would discover something, that there would be a twist. God told me that when they re-investigated the MI6 agents would be terrified.

God told me that the mysterious death was a good punishment for MI6. I noticed God had said 'mysterious' rather than 'very mysterious', and considered he was referring to

Litvinenko. God told me that after the mysterious death the MI6 agents would be afraid, and after they re-investigated, the MI6 agents would be terrified.

God told me he wanted all MI6 agents to be afraid of him.

Jesus again told me I thought everything that happened was MI5 and it wasn't always them. Jesus told people that MI5 had persecuted me in 2002.

Jesus told me I wouldn't have a major problem with MI5 in future whereas MI6 wanted to kill me. Jesus told me that in 2009 MI6 would try to kill me at the doctors.

Having looked at Britain, Jesus then looked at Russia and smiled warmly for a long time at Russia.

Jesus kept watching Russia. Jesus told me Russia was an interesting country and he liked watching Russia.

I was looking at France while Jesus continued watching Russia. There was a large dirty black nuclear reactor in North East France. It was an old one, it leaked and was filthy. I saw several spies around the nuclear reactor. 3 of the spies, one in particular - the other 2 followed him - wanted to get into the nuclear reactor. However, due to the lead one decided not to. Then the spies had gone. Then there were 3 spies around the nuclear reactor who were wanted to get in to the nuclear reactor and they went in. They wanted to take radioactive material. I wondered if it was plutonium. I wondered what they wanted the radioactive substance for. I was worried about Israel. The spies were like insects. I then saw one big spy went in to that nuclear reactor. The big

spy was different from the 3 spies, he was from the top of the government and was a good one and he was from me. The 3 spies had gone.

Jesus looked at France, was worried and quickly turned to look at America. Jesus said he didn't want to look at France because of French politicians. Jesus said if he looked at France that French politicians would get in his eye..

Jesus continued to look at America. I noticed it appeared to be empty land Jesus was looking at. I did not see any people, he appeared to be examining empty land. Jesus told me there were people there and he was examining the land. Jesus told me he would say hello. He told me the land was important and people in America were interested in the geology. I noticed it was an area of mid south easterly America that Jesus was looking at. Jesus appeared to be examining the earth. Jesus told me he was looking at the fertility. I was wondering why Jesus seemed particularly interested in that area. Jesus told me it as South Carolina where he was examining the soil fertility.

Jesus told me he was now examining the geology to see if the American plate was stable. Jesus seemed particularly interested in an area of mid south easterly America. Jesus told me he was looking at that area and that he was also looking elsewhere. Jesus told me that Americans wanted to know whether the land was stable. Jesus appeared particularly interested in the area of mid south easterly America.

I was worried Jesus had only quickly looked at France. Jesus told me he would have a bigger look at France for me and that he was busy looking at America. Jesus was interested in the geography of America. I won-



dered why he was looking at the geography not the people. Jesus told me he would look at the people and that he was looking at the geography, and that it didn't matter that he looked at the geography first.

Jesus had a look at the American people, smiled at them and was pleased. Jesus told me he was pleased as many Americans believed in him. Jesus told me it was important that people believed in him and told me there were many good people in America.

Jesus had a look at the CIA. I was puzzled there were no people as Jesus looked at the CIA. It was like America was scorched and there was nobody there, no crops and nothing there, as Jesus looked at the CIA.

Jesus told me there were people there and that the reason I could not see anyone was he was examining the CIA. I wondered if everyone and everything in America ran for cover when Jesus was examining the CIA.

Jesus told me I would see people soon. Jesus was pleased and told me he had found some good people in the CIA, and showed me. I saw a few people, they were good CIA agents who were pleased Jesus had found them. I noticed there were several. Jesus told me there were more of them. I then saw there were quite a lot.

First I had seen 5, then around 15, then around 50.

Jesus showed me there were more.

Jesus had a look at the people of France and smiled at them. Jesus told me there were a lot of good people in France. Jesus told me there

were a lot people in France who believed in him. Jesus smiled at the people who believed in him. I noticed there were not particularly many. There was a French woman in particular who Jesus smiled at.

Jesus smiled at the Muslims in France. Jesus told me that Muslims in France believed in him.

Jesus told me some people who went to church didn't really believe in him. He also said there were some people who believed in him who didn't go to church, and pointed out I was one.

Jesus said Russia's spies were well behaved in comparison to the world and in general Russia's spies were well behaved. Jesus pointed to Vladimir Putin as being responsible. Jesus explained Putin had put effort into making Russia's spies well behaved. Jesus told me he liked Vladimir Putin.

Jesus told me he was not trying to interfere in the Russian election and that, other than one when he was head of the FBS, had made no judgement on Putin's policies. Jesus said he had not endorsed Putin's other policies but had endorsed Vladimir Putin as a person, and that he was leaving judgement of Putin's policies as President to the Russian people. Jesus told me he wanted people in Russia who disagreed with Putin's policies to vote against him while having respect for him. Jesus said that as he liked Putin as a person, people should respect him.

I considered -and Jesus was pleased with me - a reason Jesus had pointed that out was many people were afraid of Putin, particularly some leaders in Western countries, and

that Jesus was pointing out to them he was a nice man.

Jesus told me he had one task for Vladimir Putin. Jesus told me that Putin had been tasked to make sure the Russian election was fair in 2015.

I saw Jesus looking at Putin with distaste in 2012. Jesus continued looking at Putin with distaste through 2012. It was apparent Putin had done something that displeased Jesus. I wondered if it was Syria. Jesus told me it wasn't Syria. I wondered if Jesus thought Putin had been in power too long. Jesus changed his expression toward Putin in 2015 and looked pleased.

Jesus went back to looking at Putin in distaste in 2012. I wondered what Putin had done. I wondered if Putin had gone bad and Jesus didn't like him anymore. Jesus indicated to me he still liked Putin, that he liked Putin in 2009 and 2015. Jesus indicated he was very pleased with Putin in 2009. I didn't know what Putin had done in 2009. Jesus told me he was pleased with Putin in 2015.

Jesus said it was normal that he was not pleased with a person all the time, it depended on what the person was doing. Jesus said he liked Putin in 2009 and 2015 and didn't like Putin in 2012, and that in general he liked Putin.

Jesus looked at Putin in 2012. "He wants to be President," said Jesus with distaste. Jesus told me there was something going on with Putin and Medvedev. Jesus told me Medvedev was President and Putin should have been loyal. Jesus told me Putin should have issued a public statement saying Medvedev was doing a good job and that he was



backing Medvedev.

Jesus told me there had been a generally fair election in Russia which Putin had won. Jesus told me there had been a generally fair election in Russia in 2015 and that he was pleased to see Putin in power in 2012 as he had won the previous election, and that he was pleased to see Putin in power as he liked Putin and the Russian people had voted him in. Jesus told me that the reason he had been looking at Putin with distaste was because he didn't like the way Putin was looking at me. I saw Putin accept the admonishment.

Jesus explained to me Putin had thought I was on LSD.

I was aware of a photograph of Putin which people thought indicated he was a paedophile. Jesus said to leave it to Russia. Jesus said the Russian people were best placed to know Putin.

Jesus pointed out that Putin had abused one child. Jesus told me he was taking a hard line on sexual abuse and taking a hard line on Putin, that Putin had abused that child in the photo and that everybody knew Putin had abused the child.

Jesus told me he was not going beyond that one, to leave it to Russia. Jesus told me not to worry, that there were big Russians who would remove Putin if they found anything like that.

Jesus reckoned Putin should not be reckless and would have to be careful or he would go up in flames in Syria in 2016. Jesus showed me Syria red in 2012 and getting worse and redder to a huge explosion in 2016

when Syria completely went up in flames and Putin in Syria went up in flames.

Jesus said he was not angry with Putin. Jesus said Putin did not have to go up in flames in Syria, and that he should try to damp the situation down. Jesus said that if Putin tried to damp the situation down, he would not go up in flames.

and saw Ukraine was the world, that the world was largely sea and that the Pacific ocean was dirty, and the world was dingy. I noticed the European countries were dingy, Jesus told me you could get World War from Ukraine.

I saw the world in 2015 and it appeared cleaner. A guy in Ukraine pointed out you could still get World War from Ukraine in 2015 and it was still dangerous. I saw Ukraine and the world appeared cleaner. I saw there was a dirty dot to the east in 2015, it appeared to be in Japan. I wondered that was mistaken and if there was trouble in North Korea.
